Criteria to consider in selecting the BoardRoom magazine's 2017 President of the Year

- 1) A club president who leads the board of directors in establishing general operating policies for the club.
- 2) A club president who supports development of a strategic plan and focuses on operating the club through a strategic plan and vision.
- 3) A club president who ensures the board focuses on policy and guidelines as opposed to micromanagement, avoiding the temptation to actually manage the club since it is the duty of the board to develop policy and guidelines while it is the duty of the management team to implement the policies and guidelines.
- 4) A president who guides the board in establishing clear and realistic goals for the general manager/COO.
- 5) A club president who can show member satisfaction relating a) to transparency in board deliberations and b) member inclusion/participation in major decisions by the board.
- 6) A club president who has successfully guided the club through a major issue; who has developed the vision to take on a major capital project successfully approved by the membership.
- 7) A president who supports ongoing education for the senior management team.
- 8) A president who has a passion for the club as a "club."
- 9) A president who can be trusted to act in the club's best interests without regard for external pressures or personal gain.
- 10) A president who has clearly demonstrated the ability to work effectively with others and who has a proven ability to be a consensus builder within the board and club.
